



Good 2 Grow Kids Tagging Ninja Service Agreement

_____ I agree to pay a \$15 up-front materials fee for up to 200 items (matching clothing sets count as 1 item). I will pay an additional materials fee of \$10 for items 201-400 (total \$25) and an additional \$10 for items 401-600 (total \$35). This should be discussed with the Tagging Ninja when items are dropped off with the Ninja.

_____ I agree to pick up my tagged consignment items from the Tagging Ninja (by appointment) on the agreed upon date once items are tagged and ready. All items that are not picked up within **48 hours** of the agreed upon date will become property of Good 2 Grow Kids.

_____ My items have been recently laundered and are without tears, stains, holes, yellowing and/or extreme fading. My items are seasonally appropriate for the current sale (Spring/Summer items for March Sale & Fall/Winter items for September Sale). Items that do not meet the Good 2 Grow standards will be returned to you **but will be included in the initial 200 item count.**

_____ My consigned clothing items have been placed in sets (by rubber banding, folding, or pinning) if they are to be sold together. Matching sets are counted as 1 item. (For example: Dress is folded over matching bloomers or shirt pinned to matching shorts.)

_____ I am consigning a car seat and attest I am the original owner of the car seat, it is less than five (5) years old, and has never been involved in an accident. And, to the best of my knowledge, it is not on a recall list and is within the CPSIA guidelines for safety (additional attestation statement must be signed at drop off).

_____ I agree to allow the Tagging Ninja to price and tag items at their discretion. My items will be competitively priced (i.e., priced to sell) unless otherwise requested. Any specific pricing requests must be agreed upon during Tagging Ninja drop off. I will not, nor will the Tagging Ninja, change or adjust any pricing once the tag has been attached to the item.

_____ All items should be marked to be discounted during the 50% final sale day

_____ items should be marked FULL PRICE.

_____ I will drop my Ninja-tagged items at the Good 2 Grow sale during the scheduled drop-off dates/times and place items on the sale floor. It is my responsibility to check Good 2 Grow's website for the scheduled dates/times and to schedule my drop off appointment. At my drop off appointment, I will sign my consignor agreement and receive my consignor passes.

_____ I understand that the Tagging Ninja service is to be used to sell items at the Good 2 Grow Kids Sale only. I understand that I forfeit the right to forever utilize the Ninja Tagging service if I do not bring my tagged items to the consignment sale at the designated drop-off dates/times.

_____ I understand that the consignor number listed below will be a Ninja Tagging number for the current sale. **Anything tagged with this number will result in receiving 50% of the item's sale price for the current sale. I will use a different consignor number if I choose to tag items on my own accord for the current sale.** I **DO / DO NOT** (circle) plan on tagging additional items on my own accord. As a courtesy, Good 2 Grow will waive one of the \$10 consignor fees, but to do so, I understand it is my responsibility to notify Good 2 Grow that I have two numbers.

_____ I realize that Good 2 Grow and the Tagging Ninja will do their best to safeguard consigned items, however they will not be held responsible for lost, damaged or stolen items.

_____ I would like to donate the items that do not sell in the Good 2 Grow sale. These items will be tagged with white cardstock --- **or** --- _____ I would like to pick up my items that did not sell in the Good 2 Grow sale on pick-up day. These items will be tagged with colored cardstock. It is my responsibility to check Good 2 Grow's website for the scheduled pick-up dates/times. I will pick these items up myself.
